GENERAL TERMS:

- 1. Prices shown exclude Value Added Tax (currently 20%) which is payable to clients in the European Union (except businesses outside the UK who supply a valid VAT number). No sales tax is added for clients outside the EU. Applicable sales tax may also be added in the USA.
- 2. We need 90 days' notice in writing for cancellation.
- 3. Our subscription licence fees are charged quarterly in advance and must be settled by via credit/debit card or some form of automatic payment. All UK clients must pay by Direct Debit.
- 4. This quotation is valid for seven days from 7 January 2020.
- Artlogic Database is a generic system and we will not modify it without prior agreement. It is subject to our Subscription Licence Agreement and our company Terms and Conditions, available from our website at https://artlogic.net/terms/
- 6. You need to have enough user licences. Additional user licences in the future are charged at the prevailing rate (currently GBP 35.00 per month).
- 7. If we are performing imports, we will make a written estimate for the timescale otherwise, set up will be completed in 5 working days of receipt of your first payment. We will set you up sooner if we can.

INCLUSIONS:

- 1. Importing data and images via our import team is excluded but we have fantastic import tools that we would encourage using. Importing one Artworks spreadsheet via the import team would cost GBP 250 providing the data is supplied in our import template spreadsheets containing no relationships with other tables, internal relationships or use of value lists that are not implied by our sample spreadsheet templates. The data must be in the correct columns in the required format. Images may also be imported as part of this process if they are a suitable size and format and named with a unique value which matches a field in the spreadsheet (e.g. there must be a direct relationship between the image filename and the artwork record such as stock number or ID). Images must be supplied in a single directory on a memory stick/Hard Disk. Images must be jpg format of type sRGB colour or RGB colour. Our import team can also provide an import of contacts for GBP 100 providing the data is also supplied on our contacts template spreadsheet. If you add columns to the spreadsheets, there is usually an additional charge and you must discuss this before delivery of the data if we have scheduled an import. You must also specify where the data should go in our system when this is not obvious.
